In July 2019, the Reynolds City Council passed a Complete Streets Policy, and the City of Reynolds Bicycle and Pedestrian Plan was completed in August 2019. The Reynolds Bicycle and Pedestrian Plan strives to improve the experience of bicyclists and pedestrians throughout the city, while also addressing issues such as education and awareness, encouragement programs, and bicycle and pedestrian facilities.

Based on community feedback, the Connecting Americus team created potential projects that would best connect the places that were identified. Alta Planning+Design out of Atlanta conducted a deep dive charrette in December 2019. The charrette brought together community members, city and county officials, and cycling advocates to discuss the future of cycling infrastructure in Americus and Sumter County. This effort is ongoing and hopefully construction will begin shortly on a network connecting neighborhoods, schools, churches, recreation centers, grocery stores, and other highly utilized places throughout the community.

Showcasing the Benefits of Complete Streets in Rural Communities through Live,
On-Street Demonstrations

In 2015, the Southwest Region Planning Commission (SWRPC) and the Monadnock Alliance for Sustainable Transportation (MAST) worked with the Town of Swanzey and the City of Keene to develop local Complete Street policies and customized Design Guidelines. These policies were the first of their kind to be adopted in the Southwest Region of New Hampshire, and the Swanzey policy represents the first rural Complete Streets policy adopted within the state. SWRPC, MAST, the Town of Swanzey, the City of Keene, and over thirty community groups and partners worked together to coordinate two "Complete Street Demonstration" events. Temporary street design elements such as narrowed travel lanes, curb extensions at pedestrian crosswalks, artistic crosswalks, street trees, pedestrian-scale lighting, shared lane markings, improved landscaping and green buffers, and other traffic calming measures provided residents the chance to experience proposed changes, provide feedback, and influence investment decisions.
